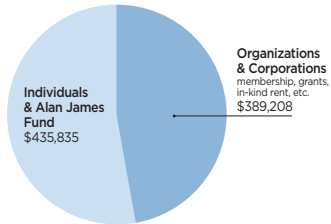

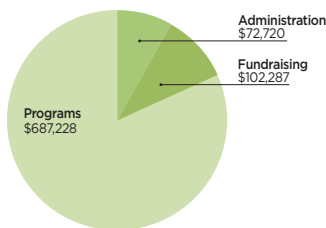

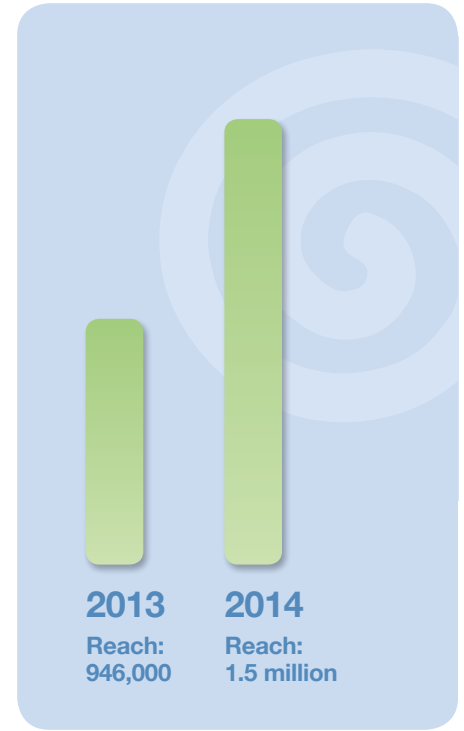

2014 A Year of Growth

2014 was a year of tremendous growth for Donate Life Northwest programs. In the fiscal year ending June 30, Oregon and SW Washington donor registrations continued to increase - to nearly 2.3 million. with more Ambassador trainings in more communities, volunteer hours nearly doubled - to some 3,000 hours - while activities outside of metro areas increased 25%.

This helped grow school, multicultural and community programs, as well as media interest - increasing direct impact by more than 63.2%. Together, the Donate Life Northwest community engaged up to 1.5 million people to build cultural appreciation for organ, eye and tissue donation.
